LIST OF HONORARY FELLOWS FOR APPROVAL AT AGM 2025

1. Ruth Rankine - approved at Council 2024

Ruth is currently the NHS Confederation's director of primary care, leading the Primary Care Network. She has for many years worked to improve primary care, and general practice in particular, through productive engagement with GPs, their teams, Primary Care Networks, GP members of Integrated Care Boards, GP federations and national bodies including the RCGP and BMA. Ruth has led the Confed's increasingly ambitious work on primary support and renewal. She established our Primary Care Network made up of PCNs, GP Federations and now Primary Collaboratives. In her leadership role Ruth has combined advocacy, influence and increasingly a focus on improvement and change. Working seamlessly with our ICS network, Ruth's impressive team has convened ICS primary leads to understand their challenges and opportunities. Among the many important projects Ruth has spearheaded are our successful annual Primary Care conference, our in-depth project on Integrated Neighbourhood Working, and our work with members and partners to develop a blueprint for the future of primary care. Ruth skilfully manages the tension between being an insider well connected and well respected by DHSC, NHSE and professional groups, with the independence as a progressive thinker working in a Confederation committed to better system, place and neighbourhood working. It is testament to Ruth's abilities and persuasiveness that the Confed is increasingly explicit about its view that primary renewal is the bedrock of the renewal of the NHS as a whole. Prior to joining the NHS Confederation, Ruth was deputy chief inspector of general practice at the Care Quality Commission. During her time at CQC she led on the delivery of the first regulatory programme for NHS general practice in England. She led the development and delivery of a regulatory programme for providers of online healthcare, working with regulators across the UK, and influenced changes to legislation. She also secured over £1m funding from the Ministry of Defence to develop and lead an inspection programme of military health facilities in the UK and abroad. In her previous role as executive director of strategy and business development at NHS Direct she was responsible for developing and overseeing delivery of the organisation's 5-year strategy and supporting business plan. She designed a national stakeholder engagement strategy and campaign, ensuring effective engagement with key stakeholders – principally Department of Health and other national and local NHS organisations and acting as a key spokesperson. She led implementation of the first NHS 111 telephone pilots in the country on time and within budget, using the results to influence the direction of national policy. She worked in the Department of Health for more than ten years, latterly as principal private secretary to the NHS chief executive and the permanent secretary.

As Director of urgent and emergency care in Leeds between 2003-2005 she led a review of urgent and emergency care processes across the health care system and led implementation of the action plan to deliver the 4-hour A&E target. She designed and led the implementation of the new primary care out-of-hours arrangements and redesigned and implemented a new pathway for patients with Chronic Obstructive Pulmonary Disease (COPD) and stroke to deliver more community-based services. She has also spent time as programme director for national GP contract negotiations for the NHS Confederation, engaging positively and productively with the BMA's GP committee. She also spent 2 years as national programme director for NHS Walk-in Centres. Ruth holds a degree in business and languages and is vice-chair of Carers First, a charity supporting carers in Lincolnshire, Essex, London and Kent.

2. Alan Wells – approved at Council 2025

In recognition of his commitment and service to the College, Alan is awarded an honorary fellowship for his outstanding contributions as Chair of the Remuneration Committee over two terms, totalling six years since 2019. During this period, Alan played a pivotal role in setting remuneration, monitoring performance of the Executive Management Team, and ensuring appropriate financial arrangements for Officers. His collaboration with the CEO, Vice Chair Finance, and member Value has been instrumental in the committee's success.

Alan's career began as a teacher before he became the founding Director of the Basic Skills Agency, where he championed adult literacy and developed numerous initiatives, including the Moser Report, the Basic Skills Quality Mark, the Employer's Pledge, and the National Basic Skills Strategy for Wales. For his services to education, he was awarded an OBE in 1994.

Transitioning to a career as a Non-Executive Director (NED), Alan served in various healthcare roles, including NED of NHS Waltham Forrest and NHS North East London and The City, Deputy Chair of Waltham Forest CCG, Independent Chair of North West London CCGs, and Lay Chair of Advisory Appointments Committee at Barts Health NHS Trust. He has also been a School Governor, Chair of an independent sixth form college, and Chair of the Professional Conduct Panel of the Teacher Regulation Agency. Additionally, he served as a Trustee of the Alzheimer's Society.

Since 2019, Alan has made significant contributions to the college, working closely with the Chair of Trustees, CEO, and Honorary Treasurer in one of its more discreet, behind-the-scenes committees. His commitment to the College and its collective endeavours has been exemplary.

3. Sheila Hollins - approved by Council 2025

Sheila Hollins graduated in medicine from St Thomas' Hospital. She worked as a GP in south London, where she realised that she could not give the care deserved by patients with mental health conditions in an appointment in a busy GP surgery. This led her to seek a way to respond appropriately to patients with complex needs and mental health conditions by training as a psychiatrist. Sheila was one of the first in her scheme to train part-time and successfully campaigned to save the hospital crèche. Appointed professor of psychiatry of disability at St George's, University of London.

In the 1980s, she sought picture books to help people with learning disabilities cope with feelings, finding nothing. When her son with a severe learning disability was a teenager, she found that drawing pictures helped him understand his experiences. She went on to work with people with learning disabilities and an illustrator to produce books without words: "When Dad Died" and "When Mum Died" (published in 1989) and edited eighty word-free stories for adults who cannot read, tackling issues such as growing up, abuse and health needs, "Books Beyond Words".

Sheila has served as a lifelong crossbench peer since 2010. Her contributions have included to mental health, as the mother of Abigail Witchalls, attacked and paralysed apparently at random by someone with substance misuse and mental health problems, she expressed compassion for the assailant and his family and the broader implications for improving access to mental health services, saying "we can lock up 100,000 people and still have catastrophes like the attack on my daughter".

Sheila was a member of the Prime Minister's Standing Commission on Carers (2007-2009), continuing her career-long campaigning to improve the lives of the carers who prop up the NHS with their contribution.

Sheila has encouraged the underrepresented, especially women, into leadership at all stages of their careers.

She has highlighted the astounding health inequalities in life expectancy between those with learning disability and those without, campaigning to reduce this shameful discrepancy. Perhaps it is here that she has most developed general practice, where we now provide learning disability medicals and support people to live in the community. She is a named author in many articles published in the BJGP or read by GPs in the BMJ. Her leadership has impacted people with learning disability and mental health conditions, their careers and primary care teams. Addressing health inequalities is a strategic priority for our college, arguably so because of the work of Baroness Sheila Hollins.

4. Samantha Scallan – approved by Council 2024

Sam started working at Wessex Deanery in 2004 and was then appointed as a medical education researcher working with the GP Dean of the time, Professor Frank Smith on GP workforce. Sam is recognised nationally and internationally as one of the foremost non- medical primary care researchers publishing nationally and internationally. She has worked for the NIHR as a reviewer of their funding awards committee and is deputy editor of one of the principle primary care education journals (Education for Primary Care also known as the Green journal). She has been an integral part of the research unit of the school of primary care at Wessex Deanery, providing support to the GP Dean, Associate Deans, programme directors and specialty GP registrars. She helps the education and leadership ST4 fellows with their research and it is entirely due to Sam that the ethos of research is so strong in Wessex.

Sam is the programme lead for the Masters in Medical Education at Winchester, the certificate until recently being compulsory for all GP trainers in Wessex. She also worked closely with the Wessex Appraisal Service offering a tailored Masters for their GP appraisers. Sam is also the chair of the University Ethics Committee, a position that is held in very high regard.

Sam's work with the appraisal service has led to co-authored papers on GP appraisal and revalidation, progressing the understanding of the impact of appraisal and revalidation. She is an excellent emissary for our profession and specialty and her name is held in high regard within the education world.

Sam is a reviewer of qualitative studies for the British Medical Journal, the British Journal of General Practice, Medical Education and Medical Teacher. She has published widely in Education for Primary Care, Clinical Teacher, International Journal of Clinical Leadership, British Medical Journal and Medical Education. Sam has presented at national conferences including the RCGP, UKCEA, ASME, BMJ evidence and internationally at AMEE and Ottawa.

Without doubt Sam has professionalised the research in primary care education and promoted education research through her collaborations with many other deaneries. We are very proud to

have her as a colleague and to recognise her astounding contribution with honorary fellowship of the college.

5. Chris Askew - approved Council 2025

Chris Askew OBE served as Chief Executive of the Royal College of General Practitioners from 2021 to 2023, leading the organisation with vision, skill and integrity. During this time, he guided the College through a period of significant challenge, laying the foundations for financial sustainability and long-term organisational stability.

He oversaw the creation of a clear and ambitious corporate plan, rebuilt the directorate structure and appointed a strong leadership team, and developed excellent communications across the organisation. Chris has been widely admired for his inclusive and inspirational approach, building confidence among staff and members and strengthening the College's relationships with partner and sister organisations.

Always calm, diplomatic and values-driven, Chris managed complex and sensitive situations with professionalism and respect. His outstanding leadership reflects a long and distinguished career across the charity sector, where he has previously led major organisations including Diabetes UK and Breakthrough Breast Cancer. In 2020, he was awarded the OBE for services to the charity sector.

As Chair of Trustees, I want to place on record my personal thanks to Chris for his wisdom, integrity and inspiration throughout his time at the College. He leaves a legacy of strength, optimism and stability for the future.

It is with great pride that we award him an Honorary Fellowship of the Royal College of General Practitioners.
